



Truth in Savings Account Information	Rate and APY Information	VIEW CURRENT RATES
	Rate Information	Your interest rate and annual percentage yield ("APY) may change.
	Frequency of Rate Changes	We may change your interest rate on your account at any time.
	Determination of Rate	At our discretion, we may change the interest rate on your account.
	Compounding and Crediting Frequency	Interest will be compounded daily and credited to your account monthly.
	Minimum balance needed to open account	You must deposit a minimum of \$.01 to open this account
	Monthly Maintenance Fee	There is no monthly maintenance fee associated with this account. However, other service charges or fees may apply. Please see separate Disclosure of Service Charges.
	Daily Balance Computation Method	We use the daily balance computation method to calculate the interest on your account. This method applies a daily periodic rate to the principal in the account each day.
	Accrual of Interest on Noncash Deposits	Interest begins to accrue on the business day you deposit noncash items (for example, checks).
	Minimum Balance to Earn Interest	There is no minimum balance requirement to obtain the disclosed APY.
	Effect of Closing Account	If you close your account before interest is credited, you will not receive the accrued interest
Transaction Limitations	After opening an account with a minimum deposit, you can deposit any amount over \$1.00 in your account. Funds can be withdrawn by a withdrawal order signed by you or by writing a check. Unlimited withdrawals are generally permitted in person or by mail.
